## Recipe Corner: Pumpkin Bread & Muffins

### <u>Ingredients</u>

- 1 (18.25 ounce) package spice cake mix
- 3/4 cup white sugar
- 1 (15 ounce) can solid-pack pumpkin
- 2 eggs, beaten
- 1/4 cup milk
- 1/2 cup mini chocolate chips (optional)

#### **Directions**

- 1. Preheat oven to 350 degrees F (175 degrees C). Grease a loaf pan and 24 mini-muffin cups.
- Stir cake mix and sugar together in a large bowl.
  Beat pumpkin, eggs, and milk with the cake mix
  mixture until you have a smooth batter. Stir
  chocolate chips through the batter.
- 3. Drop batter into prepared muffin cups with a small cookie scoop. Pour remaining batter into greased bread pan.
- 4. Bake muffins in preheated oven until tops of muffins are golden and spring back when lightly pressed, 12 to 14 minutes.
- 5. Bake bread in preheated oven until top is golden and springs back when lightly pressed, 55 to 60 `.
